- Furthermore, The "Lessee" shall indemnify and hold harmless Okaloosa County and the Baker Area Recreation Association Inc., their subsidiaries or affiliates, elected and appointed officials, employees, volunteers, representatives and agents from any and all claims, suits, actions, damages, penalties, interest, attorney and paralegal fees, liability and expenses in conjunction with the loss of life, bodily or personal injury, environmental impairment, property damage, including loss of use of the property, zoning or similar issues, directly or indirectly caused by, resulting from, arising out of or occurring in conjunction with the "Lessee's" negligent performance of the agreement. Nothing contained in this agreement can be deemed by the parties or by a third party to create the relationship of principal and agent, partnership, joint venture or similar relationship between Okaloosa County, The Baker Area Recreation Association Inc. and the "Lessee".

- Vendor agrees that no refund whatsoever will be made by Baker Area Recreation Association Inc. for loss, fire, inclement weather, etc. The Baker Area Recreation Association Inc. reserves the right to cancel this contract at any time with moneys refundable.
